


Warnings and Cautions

Shut off power at the circuit breaker or fuse panel before removing the old fixture or installing the new one.

LEDs can be damaged by electrostatic discharge shock. Before installation, discharge yourself by touching a grounded bare metal surface to remove this hazard.

For INDOOR use only. For electrical requirements, see fixture. Minimum 90° C supply conductors.

THIS FIXTURE IS DIMMABLE BY SPECIFIC FORWARD PHASE ELECTRONIC (TRAIC) DIMMERS AND IS NOT COMPATIBLE WITH 0-10V DIMMING SYSTEMS. Dimmers tested to be compatible with this fixture are the Lutron: Diva® C•L™: DVWCL-153P or DVCL-153P, Lumea® C•L™: LGCL-153P, and Toggler® C•L™: TGCL-153P. (This list of dimmers does not imply any guarantee or warranty of compatibility with a particular application. Dimmers not listed do not imply non-compatibility.)







At its discretion, PATRIOT LIGHTING® agrees to have the product or any defective part(s) repaired or replaced with the same or similar PATRIOT LIGHTING® product or part free of charge, within the stated warranty period, when returned by the original purchaser with the original sales receipt. This warranty; (1) excludes expendable parts including but not limited to light bulbs; (2) does not cover damage that has resulted from abuse or misuse; and (3) does not cover any losses, labor, injuries to persons/property or costs. 
- Remove diffuser and decorative ring secured to fixture pan by unscrewing post caps.
- Identify threaded holes in universal mounting bracket (AA) by aligning with mounting keyholes in fixture pan. Attach fixture mounting screws (BB) 1 into threaded holes and leave extended about 3/8 in. Attach mounting bracket to electrical box, using existing electrical box screws (2).
- Pull fixture wires through hole near center of fixture pan to backside of fixture. Using support chain (CC), connect one end to back of fixture pan near center in specially designed slots. Hook other end of support chain to electrical box to temporarily hold fixture for wiring.




Fixture must be properly grounded. Connect fixture ground wire to ground wire in electrical box using wire nut (DD). These wires can be either green or bare copper. Insert black supply lead into connector on black fixture wires and white supply lead into connector on white fixture wires. Push excess wire into electrical box.



Femove support chain. Insert first screwhead into straight keyhole slot (1), pivot fixture and insert second screw into curved keyhole slot (2). Once screws are engaged, maneuver fixture into desired position. Tighten screws.



- 6A Locate the 3/4 in. open holes for mounting at each end of fixture pan and drill a 1/8 in. pilot hole in the center. If a wooden stud is encountered, use the wood screws (FF) and washers (EE) provided to secure fixture directly to stud.
- fb If no stud is encountered, place the drywall anchors (GG) in the pilot holes and screw them into place until flushed with surface of drywall. Place washer (EE) over the mounting hole and drive long screws (FF) into drywall anchor until snug. Do not OVERTIGHTEN. Note: Main support for fixture is provided by attaching to a securely mounted electrical box. If the electrical box is not properly secured, alternative mounting methods such as toggle bolts (not included) should be used to secure fixture.



7 Place diffuser and decorative ring against fixture pan. Once holes are aligned, hold both diffuser and ring in place and attach post caps to secure decorative ring.
